TERMS OF ENROLLMENT

1. Fees include food, lodging, linens, blankets, and towels. Medical services beyond those routine supports provided by the resident nursing staff must be covered by participant's own insurance.
2. Round trip transportation from NJY designated JCC's and Y's is included in the fee. No refunds will be made to participants who use their own transportation.
3. Rooms are assigned by the Kislak Center administration based upon administrative and service policies, reserving the right to make changes. Every effort will be made to accommodate room-type requests; however, if your particular selection is unavailable, you will be notified of available options. All rooms - both singles and doubles have private bathrooms. **FIRST COME-FIRST SERVED! REGISTER EARLY!**
4. A Kislak medical form must be submitted at least 30 days prior to arrival. Participants must be in general good health. Participation in the program may be denied if the health form is not received.
5. Reservation deposit of \$100 PER PERSON must accompany the application. Balance is due 45 days prior to trip.
6. Kislak is herein authorized to use analog and/or digital photographic, audio and/or video reproductions of guests electronically and in literature for interpretive purposes, advertising and to participate in research studies conducted by the NJY Camps.
7. When you provide a check as payment, you authorize us either to use the information from your check to make a one-time electronic fund transfer from your account or to process the payment as a check transaction.
8. It is agreed that any dispute or cause of action arising between the parties, whether out of this agreement or otherwise, can only be brought in the PA Court of Common Pleas located in Wayne County, PA, and shall be construed in accordance with the laws of Pennsylvania.
